Whereas the founder has for long time felt the need for providing better economically bearable but professionally uncompromised education along with medical social economic facility to the underprivileged /needy people of the society.


To further carry out the noble work of the society the founder is establishing a trust i.e.

And WHEREAS to efficiently conduct the objects has appointed the trustees and the trustees of the Trust has agreed to carry on the Trust and to faithfully discharge the confidence reposed in them.

NOW THIS DEED OF THE TRUST WITNESS AS UNDER :

1. **Name of the Trust:** That the Trust shall be known as **"RAMRATI DEVI EDUCATIONAL TRUST"** for the objective herein mentioned and hereby relinquish all claims or rights in the above said transferred sum.
2. The founder of the Trust named above hereby conveys and transfers a sum of Rs. 11,000/- (Rs. Eleven Thousands Only) in favour of **"RAMRATI DEVI EDUCATIONAL TRUST"** for the objectives herein mentioned and hereby relinquish all claims or rights in the above said transferred sum.
3. That the Trust fund shall be the said amount donated by the Founder named above and all creations, acquisitions contributions, donations and bequests whether in cash or in kind as income of the Trust.
That donation towards corpus fund will not be treated as Income. That trust shall have inherent right to declare any donation as corpus fund to meet expenditure either of recurring in nature of otherwise. Any income generated from Corpus may be retained as part of the corpus fund or may be used to meet the expenses of the trust as the need may be.
4. **Office of the Trust and Jurisdiction:** The Registered & Administrative office of the Trust shall be at H. NO 390, Village & Post Jarcha, Tehsil Dadri, Gautam Budh Nagar UP 203205. However, the same can be shifted to any other premises or Land acquired for the purpose of the trust in any other part of India by the decision of Trustees. The jurisdiction of the Trust shall be at Dadri, Gautam Budh Nagar.

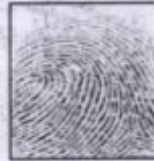



5. **Object of the Trust:** This trust is created for carrying out all the objects including the following objects for public charity within India or outside India and for the benefit of the society.

- a) To provide, promote and restructuring higher education facilities in the field of Nursery, Primary, Middle and Higher/Senior/Secondary education of the needy student intellectuals and other persons of the society belonging to any cast, creed & religion etc.
- b) To engage teachers, professors, instructors, professionals, Management personals, Technical advisors and experts of good moral character and having capability to impart efficiently up-to-date knowledge to students in Nursery, Primary, Middle and Higher/Senior/Secondary education intellectual and other usual pursuits for the benefit of general public.
- c) To establish, construct, maintain and run group of faculties, universities in different field, colleges, institutions, polytechnics for imparting all sorts of education in the field of Medical, Para Medical, Engineering, Management, Computer Science, all vocational courses, Nursery, Primary, Middle and Higher/Senior/Secondary education in India or outside the India to children, boys, girls, men & women.
- d) To establish acquire, purchase, construct, maintain, hospitals, health care centers, recreational centers, diagnostic centers, nursing homes, nursing schools, clinic, old age homes and convalescent home with modern facilities, maternities homes, working women hostels, child welfare centers, and dispensaries for the benefit of general public.
- e) To establish, acquire, construct, maintain and run Auditorium, Sports Complex, Play grounds, for the furtherance of skills of sports, athletics etc.
- f) To establish, maintain, and run crèches, working women hostels, boarding houses, boarding schools and residential accommodations for needy peoples of the society and to assist, support, establish, maintain libraries, including Medical library other educational facilities including internet, reading room etc.
- g) Helping and setting up Yoga and Meditation centers and organize camps for such motives for the benefit of public at large.
- h) Rendering hand of assistance for any public charitable purpose.
- i) To do all such acts and activities for the upliftment of schedule castes, schedule tribes and other backward and minority classes of people.



- j) To develop a healthy as well as critical attitude towards the development to mental, physical and moral upliftment of the students and those connected with the institutions so as to make them good citizens.
- k) To apply and accept donation, grants from govt., presents and other offerings and to deal with the same for the purpose of the trust.
- l) To charge moderate tuition fees and otherwise recoup themselves for the outlays and expenses incurred in the upkeep and maintenance of institutions established or about to be established under this Deed.
- m) To train or acquit pupils so as to be self - supporting in an honorable and decent way of life so as to develop into good, healthy and progressive citizens.
- n) To develop discretionary conduct and a habit to observe the rule of law and self - reliant.
- o) To bring out, encourage and develop the inventive and research facilities of the pupils and teachers and to afford opportunities for research work in Medical Sciences, Art, Science, Industrial & Information Technology and other allied areas of these types.
- p) To receive and maintain in a fund or funds and to administer and apply the income and principal thereof for the furtherance of the objects of the Trust.
- q) To acquire on lease or by purchase or otherwise any moveable or immovable properties including pieces of land or built properties thereon of any kind under any name and style for the use of Trust and fulfillment of its objectives.
- r) To manage, sell, transfer, let out by way of lease, license or otherwise dispose of or deal with the assets / properties of any kind both moveable or immovable belonging to the trust.
- s) To enter into any agreement or arrangement with any other Society, Foundation, or any other party having any legal entity or any individual for the smooth functioning and achievements of the objectives of the Trust in a better way.
- t) To establish and grant scholarship, prizes for the students and others showing distinctive performance in education and other field of operation.
- u) To sponsor the deserving, needy students for their higher education in India or outside India to pay them their tuition fees and all other expenses.
- v) To take up any other activities as deemed appropriate towards public interest as and when decided by the trustees.



- w) In the event of winding up of the trust at any point of time , the whole of the corpus fund and other funds ,all movable and immovable properties belonging to the trust or the institution run by the trust shall only be transferred to any other public charitable Trust Or Institution having the same aim and objects for the Public Charitable Purposes .

6. Administration of the Trust: The Administration of the Trust shall be vested in the hands of Trustees, who shall not be less than two in number and shall be known collectively as the Board of Trustees and all decisions of whatsoever nature pertaining to trust shall actively be taken by the principal of simple majority in writing . In case of dispute of whatsoever nature, the decision of the "Chairman of the Trust" shall be final and binding in all respect.

7. Trustees & their appointment



- a. The founder of the one part & the trustees of the other part shall be the first trustees of the trust for their life.
- b. The male descendants of the "Founder of the one part" shall hold the office of the chairman in his place for their respective lives after his life. In the event of non existence of the "Founder of One part" or his descendants, the nominee of the "Founder of One part" shall become the founder of one part. The nomination so made by will or otherwise shall be made known to the Board of trustees in presence of all other trustees.
- c. The Board of trustees shall have full & final power to co-opt any person as a trustee of the trust at any point of time by unanimous decision of all the trustees. However, the total number of trustees shall not be more than seven.

8. Resignation of Trustee: In the events of the trustees intending to withdraw from the trust or submits his resignation the same may be allowed by the Board of Trustees by simple majority decision.

9. Removal of Trustees: In case of the trustees feel that any other trustee is not working in conformity with the aims and objectives of the trust or other wise feel that his working is not in the interest of the trust, that particular trustee in question may be removed from the trusteeship by a unanimous decision of all other trustees. In any circumstances and eventualities, the founder of the one part of the Trust cannot be removed or impeached by any resolution of the trustees either in individual or by collective decisions. The chairman may himself resign his post.

10. Office Bearer of the Trust: The office bearer of the trust shall be appointed by the founder of one part either by selection or by nomination or by mutual agreement either from the existing or future trustees.

The following will be the office bearer of the trust:



- a. Mr. Pradeep Kumar Mangal, Chairman
- b. Mr. Puneet Kumar Mangal, Secretary
- c. Mr. Ashish Kumar Singhal, Treasurer
- d. Such other posts as may be deemed necessary for the functioning of the trust or for all of any instruction run by the Trust for a specified period of time in writing during such appointment.

However, such post may be increased and decreased as per the need with the consultation of all trustees and chairman.

11. **Power & Function of the chairman of the trust:** The Principle, director, chief coordinator and all other executives shall be appointed by the chairman of the Trust in consultation with the board of trustees to handle the objectives of the trust or institution of the trust. The chairman of the trust shall be the link between the executive officer viz chief coordinator director etc. and the Board of trustee etc.


12. **Power & Function of the Trustee and Other Office Bearers:**

The Sole Trustee may exercise any or all of the powers vested in him under the relevant Laws. The Sole Trustee is also empowered to exercise the following powers:

- a) To receive for the objects of the Trust, any movable and/or immovable assets and properties by way of voluntary bequeaths, gift, donation and subscription.
- b) To purchase or acquire in any form or manner movable and/or immovable assets and properties by utilizing the corpus or any part thereof for furthering the objects of the Trust.
- c) To sell, transfer, assign, assure, exchange, mortgage, lease, gift, dispose off or alienate any property of the Trust in compliance with applicable law.
- d) To invest and reinvest the principal amount and income of any funds and corpus of the Trust in such assets and properties, movable and immovable, as shall be deemed necessary in compliance with the provisions of law.
- e) To sue and when sued to take all necessary steps to safeguard the interest of the Trust in any matter which may arise from time to time.
- f) To assist and support any other Trust, or Institution having similar objects by way of donation, gift or bequest.
- g) All policy decisions shall be taken by the Board of Trustees and conveyed to the chairman for its implementation.
- h) The Chairman shall get the decision of the Board implemented through Director/Chief Coordinator or any other incumbent employed/working in the

trust. In case of any dispute arising out of any decision, the verdict of chairman & Secretary Jointly shall be considered as full and final and binding on the Board of Trustee.

- i) To pass accounts of the trust and consider any recommendation made in regard thereof at a general meeting.
- j) To enter into & secure the fulfillment of any contract or engagements or behalf of the trust, compound or abandon any legal proceedings by or against the trust and to refer any matters, claims or demands or the arbitrate, observe and perform the awards.
- k) To employ instructor, and personnel as may be considered necessary for the said purpose and to employ skilled workers and professionals, advisor to carry out the objectives of the trust and to pay such remuneration as may be considered expedient for the purpose.
- l) To provide for funds for all or any objectives of the trust in manners as may considered expedient.
- m) To pay all expenses, preliminary or incidental to the formation of the trust and its registration
- n) To make rules & regulations and bye laws for conducting smoothly and successfully the affairs of the trust in a better and planned way and to amend or alter the same.
- o) Generally, do all such things as the trustees may consider expedient for the purpose of carrying out the objective of the trust.
- p) Trustee shall not do such things or act which directly or indirectly accrue in any benefits and effect implied or expressly to the founder Trust of one part & other Trustee(s).
- q) Trustee shall be empowered to do all such things and acts for public charitable purposes which are in benefits and provide all necessary relief and help to the needy and the poor persons belonging to any caste creed or religion.
- r) Trustees are empowered to fulfill the objects of the Trust and to do all other things under the name & style of the Trust i.e. "RAMRATI DEVI EDUCATIONAL TRUST" or to open separate institution independently or in collaboration with foreign institution to be under any name and style to fulfill the aims and objects of the trust.
- s) In addition to powers & authorities by the present or otherwise expressly conferred up on the Board of Trustees, the chairman & Secretary jointly shall be



empowered to exercise all such powers and do all such acts which are not expressed otherwise.


13. Rules of the Trust:

- a. Every Meeting of the Board of Trustees shall be chaired by the Chairman and in his absence Secretary shall chair the meeting.
- b. Such a meeting shall be held once in three months or with in a period as decided by the Board of Trustees.
- c. Minimum two members of the Board of Trustees present in person shall constitute a quorum at any meeting of the Board of trustee. However, the presence of chairman or Secretary will be necessary for the purpose.
- d. Chairman/Secretary may call by requisition in writing a meeting of the trust at any time.
- e. For official purposes each financial year shall be deemed to commence from 1st April every year and terminate on 31st March of the next calendar year.
- f. Each Member of the Board of Trustees shall have one vote.
- g. The decision of the Chairman & Secretary of the trust jointly shall be final & binding on all in the event of difference of opinion among the trustees on any matter what so ever.
- h. The Board of Trustees may by General or special order; direct that any resolution to be placed before the meeting, may be passed by circulation amongst all the trustees. Any resolution so circulated and approved by majority of the trustees signing the circular shall be effective and binding as if such resolutions had been passed by at a meeting of the Board of Trustees.

14. Recording of Proceedings: The Secretary shall ensure minutes to be duly entered in the book provided for the purpose.





- a. The Trustees shall hold the meetings regularly provided that at no time interval between two successive meetings shall exceed 6 months. The meeting of the trustees shall be conveyed by giving a ten clear days notice for attending the meeting or earlier in case of urgency.
 - b. Notice of meeting of the Board of trustees shall be sent under postal certificate and deemed to have been served if addressed to the trustees at the address given for the purpose.
16. **Borrowing on behalf of Trust:** To borrow funds from Government, Financial Institutions, Banks or from any other corporate or otherwise on interest or without interest in fulfillment of the objectives of the Trust i.e. to purchase land, construct building, projects, equipments and all other movable or immovable properties required for the fulfillment of the objectives of the Trust. The Chairman & trustees as authorized by the Board of trustees are empowered to execute all necessary documents for borrowings the funds as mentioned above.
17. **Bank Accounts & their operation:** The Board of Trustees shall open/ close / maintain the account/accounts with any nationalize/schedule/corporate bank in the name of the trust or in the name of any institutions run by the trust for fulfillment of all or any object of the trust and the same shall be operated by chairman and secretary. Such account/accounts may be operated by Chairman or either of trustees as per the nomination by Board of Trustees jointly or as may be authorized by the Board of Trustees from time to time.
18. **Restriction of Application of Trust Fund:** It is expressly cleared that no part of the Trust property, its income, and accumulation of Income of trust shall be utilized or applied for any purpose which is not a public charitable purpose under the Income Tax Act, 1961 and all revision thereof shall be constructed accordingly.
19. **Power to make rules & regulation:** It shall be lawful for the board of trustees & executives from time to time form such rules and regulations for the management and administration of the trust and its charities as they shall think fit and to alter or vary the same from time to time provided that such rules shall not be inconsistent with the main object of terms & consistent of the presents Trust.
20. **Alteration/Amendments:** It shall be lawful to make amendments if unanimously agreed upon by the trustees for the time being in the provisions of these presents at their accord or at the directions of the Income Tax Authorities which the trustees may be required to make to fulfill the condition for seeking recognition of constitution and recognition of the trust for the purpose of Section 80 G of the time being in force but without prejudice to the main objects of the trust. The points where no express provision has been made in the presents the provisions of Indian Trust Act, and the statutory modification thereof shall apply.
21. **Accounts/Audit & Statutory Compliance:**





